1 Briefly describe the organization's mission: Bridges to Community, Inc. currently works in four regions of Nicaragua, where they undertake projects in housing, education, health, and economic development with the help of seven-to-nine hundred volunteers from North America and elsewhere.

Service learning program organizes and facilitates cross-cultural service learning and community development trips for groups of volunteers from north america and elsewhere to travel to materially poor nicaraguan communities where they live and work alongside the community members on week-long development projects.

4b (Code:) (Expenses \$ 318632. including grants of \$) (Revenue \$ 316348.) Housing program builds homes for materially poor nicaraguan families using volunteers in the service learning program, local construction laborers, and community volunteers. The recipients of the house pay a portion of the house cost into a community fund to create a sustainable long-term improvement for those communities.

4c (Code:) (Expenses \$ 223842. including grants of \$) (Revenue \$) Education program identifies promising young people in nicaragua who lack educational opportunities and provides scholarships to those students. The students are required to engage in volunteer community service within their own communities as a method of sustaining the impact of the aid. Education program also builds and/or expands schools in materially poor communities to provide greater educational opportunities within those communities.
