About Bridges to Community

Bridges to Community (EIN: 13-3731405) is a nonprofit that builds meaningful, long-term partnerships with underserved communities in the Dominican Republic. We unite local leadership and international volunteers to drive progress in education, infrastructure, and capacity.

Since our founding in 1993, we have mobilized almost 20,000 volunteers to help build and repair over 1,681 homes and sanitation facilities in partnership with underdeveloped communities in the Dominican Republic and, previously, Nicaragua. We view shelter as the starting point to support community members to begin thriving in other ways, especially as it relates to physical, mental, and financial health. Our programs emphasize building long-term sustainable growth and resilient, empowered communities.

About the Position

The Treasurer will help steward the financial health of the organization by providing fiscal oversight, partnering with staff to review budgets and financial reports, and supporting our commitment to transparency and sustainability. Ideal candidates bring experience in finance, accounting, and/or financial management, and a passion for our mission to provide in-depth mindfulness programming for youth and the parents and professionals who support them.

The Bridges to Community Board of Directors attends to organization-wide issues and maintains a big picture, systems perspective. The Board provides governance and financial oversight and fulfills the legal roles and responsibilities of operating a 501(c)3 nonprofit. Board members support Bridges to Community's mission and vision and serve as ambassadors for the organization.

Board Member responsibilities include virtual attendance at regular board meetings (quarterly), as well as committee meetings. The Treasurer is part of the Executive Committee and is the Chair of the Finance Committee. The individual may decide to volunteer on other committees. All Board Members hold a fiduciary responsibility for management of organizational capital and ensuring appropriate filings with federal, state, and local authorities consistent with the organization's status as a 501(c)(3) nonprofit organization. Time and Financial Considerations

- Meetings: The board meets for one hour quarterly and occasionally will have a two-hour meeting, as needed
- Committee Work (as applicable): executive committee and finance committee meetings, as needed
- Work with staff: oversight of annual budget development
- Review monthly financial reports, present to board quarterly
